This licence is granted at the sole discretion of the Licensor and may be withdrawn at anytime and if the Licensee:

- 1 Fails to comply with the Pier21 Yard Rules and all health and safety requirements as notified from time to time
- 2 Fails to comply with its health and safety obligations to take all reasonable care for the safety of its workers, agents, invitees or visitors, or other persons who are lawfully present on site; or
- 3 Fails to maintain Public Liability Insurance for a minimum of NZ\$2,000,000-00 (Two million NZ Dollars).

The Licensee accepts and undertakes that it will:

- ensure that any work being undertaken at Pier21 either by the Licensee or at the Licensee’s request or instigation complies with all health and safety requirements, practices and procedures, including the requirement to have a health and safety management plan;
- ensure that any tradesperson engaged to carry out work on the vessel at the marina holds a current service providers access licence from the Licensor;
- when requested, provide the Licensor with documentation providing evidence of health and safety management compliance and practices;
- ensure that all of its workers, agents, invitees or visitors comply with the Licensor’s health and safety requirements as may be notified by the Licensor from time to time;
- report all incidents, accidents and property damage to the Licensor;
- immediately notify the Licensor if it identifies any actual or potential health and safety risk or hazard at Pier21 (that is not already the subject of a health and safety management policy or plan), whether due to the activities of the Licensee (or any of its workers, agents, invitees or visitors) or otherwise; and
- comply with any prohibition by the Licensor imposed on the Licensee (or any of its workers, agents, invitees or visitors) from accessing any part of Pier21 if the Licensor considers that person represents a health and safety or security risk to themselves or others.

This licence is not transferable and valid only to the Principal Holder

Any change of details as advised on the licence must be advised in writing to Pier21 Ltd. Any changes not advised will render the Licence invalid.
